President: On 5/12/25 President Kim Miller reported to the Board of Directors via email that she was advised of a price increase in the NCCC annual dues. The unfortunate result is for COB to raise their annual membership dues. She mentioned a possible argument was that we don't need NCCC and asked if anyone was aware of another insurance coverage option. She also believes Corvettes of Bakersfield, especially with the Gambler's Classic event, needs insurance.

In accordance with the Bylaws of COB, Inc. Article III Section 3 states annual membership dues for the following membership year are set by the Board each May.

Board member input:

COB NCCC rep/Governor Linda Stacey reported this increase was due to the rising costs of NCCC expenses. Insurance rates are increasing. The postage to mail membership cards and Blue Bars has increased. The NCCC is moving to reduce other costs like attending meetings by moving to Zoom meetings.

The governors were told that the matter was tabled until September only as a matter of following their bylaws. Our governors all voted to approve the increase.

Diane Wallace suggested a side-by-side presentation of what NCCC charges and what we're charging so that the membership understands why the increases are necessary.
